ADVERTISEMENT FOR BIDS

Sealed Bids for the **Regional Water Transmission Riverside Road Project – Supply and Delivery of Ductile Iron Pipe Materials**, will be received by the **Lancaster County Water and Sewer District** at their office located at **1400 Pageland Highway, Lancaster, South Carolina 29720**, until **2:00 P.M.** local time on **June 20, 2024**, at which time the Bids received will be publicly opened and read.

The Lancaster County Water and Sewer District will purchase the pipe and fitting materials listed in the attached bid form for the Regional Water Transmission Riverside Road Project. Materials delivered prior to the start of construction will temporarily be stored at a 1.916-acre site owned by the Lancaster County Water and Sewer District on Industrial Park Road (S29-660). The address of the site is 2068 Industrial Park Road, Lancaster, South Carolina 29720. Material delivery after the start of construction will be made directly to the job site.

Bids must be enclosed in a sealed envelope, addressed to **Lancaster County Water and Sewer District, Attn: Wes Carter, PE, 1400 Pageland Highway, Lancaster, South Carolina 29720 via FedEx, UPS or private delivery service. A standard mailbox is not present at this address.** The outside of the envelope must be marked **“Bid for Regional Water Transmission Riverside Road Project – Supply and Delivery of Ductile Iron Pipe Materials”**. The envelope must also bear on the outside, the name of the bidder and bidder’s address. All bids must be made on blank forms provided or as provided by Addendum prior to the bid.

All bidders must obtain copies of the Bid Documents from Duncan-Parnell as outlined above.

No bid may be withdrawn after the scheduled closing time for receipt of bids for a period of 60 days.

Bidders must comply with the President’s Executive Order No. 11246, as amended, which prohibits discrimination in employment regarding race, creed, color, sex, or national origin.

Lancaster County Water and Sewer District reserves the right to reject any or all bids and to waive informalities and technicalities.

This project is being funded in whole or in part by the South Carolina Infrastructure Investment Program (SCIIP), which is administered by the South Carolina Rural Infrastructure Authority (RIA) and funded by federal State and Local Fiscal Recovery Funds (SLFRF) through the American Rescue Plan Act (ARPA). All federal SLFRF requirements and SCIIP requirements will apply to the contract. All bidders and subcontractors are required to be registered in the federal System for Award Management (SAM) and

may not be debarred from doing business with the federal government. Respondents on this work will be required to comply with all applicable federal regulations, including those listed in Exhibit A.
